<b>Step-1</b>	: Applicant filing RTI Application through web address: <a href="http://www.rtionline.delhi.gov.in">www.rtionline.delhi.gov.in</a> or Applicant filing RTI Application through speed part or other permissible mode + uploading the same at RTI Portal by Nodal Officer (RTI).
<b>Step-2</b>	: Nodal Officer (RTI) shall forward the RTI Application and concern PIO/return the RTI to applicant in case of requirement of any document.
<b>Step-3</b>	: Disposing the RTI Application as for the RTI Rules & Act 2005 by the concerned PIO at his login credential.
<b>Step-4</b>	: SMS/Email shall be sent to the Applicant automatically by the NIC.

All concerned are requested to go through the user manual, as available in the 'Utilities Tab' on the main page after login.

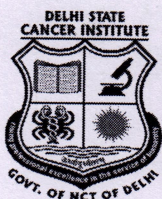

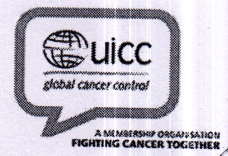
